SUMMARY

BACKGROUND/HISTORY

The LGAQ Annual Conference will be held 16-18 October 2023 at the Gladstone Entertainment Convention Centre. The event brings together Councils from all parts of the state for professional development and networking, and to debate issues of importance to their communities.

Motions for the LGAQ Conference are required to be with the Association by 8 August 2023 and will be submitted using the LGAQ's LG Online system.

| Background (required) 350 word limit | The purpose of such change is to ensure that local government becomes constitutionally an independent third level of government in Queensland and so that financial allocations from the Commonwealth are made constitutionally certain. |
| | It is to be remembered that constitutional recognition at the federal level has failed in 1974, 1988 and 2013. Given the difficulty of such constitutional change, it is seen as prudent that proper attention be given by delegates at a special conference to this very important matter. |
| | The aspiration for such recognition is to achieve legal and financial certainty as well as to reflect contemporary governance and finance practices and not those that applied in the late 19 th century and early 20 th century. |
