### **Proposal to Refurbish Council Owned Land**

Department of Public Works has resurrected its proposal to undertake an upgrade to the area of Council owned land on the corner of Douglas and Hasting Street, adjacent to the new Government owned office building.

The proposal includes the construction of a shade structure, table and seating amenities on the site and installation of new landscaping. The project will also provide the opportunity for the inclusion of additional artwork or designs into or adjacent to the amenity. This could provide local emerging artists opportunities to design the art for the project.

The Department is seeking 'in principle' agreement in writing from Council to progress this proposed project. I have already sought advice from the Chief Executive Officer and the Engineer.
