MAYOR'S REPORT

Royal Visit to Queensland

Her Excellency, Ms Penelope Wensley, AC, Governor of Queensland extended an invitation for the Mayor to attend a Luncheon with other special guests held at Brisbane on 24th October 2011 on the occasion of the visit to Queensland by Her Majesty The Queen and His Royal Highness the Duke of Edinburgh. I was honoured and humbled to part of the Queensland representatives to participate in this once in a lifetime experience.

Torres Shire Fluoridation Program

Mr. Colin Bishop has been persistent in lobbying support against the introduction of fluoridation into the Shire's water systems. I have requested that Dr. Maria McGowan present an information session to update councillors as soon as possible. An invitation has been extended to Dr. McGowan to attend the December meeting. Council must ensure that recurrent funding is secured for the operation and maintenance of fluoridation system before it is connected with the Council's water supply.

Integrated Service Delivery Meeting

The Torres Strait Regional Authority has proposed to hold the Inaugural meeting of the Integrated Service Delivery Board of Management at Cairns on 12th December 2011. An invitation will be extended to Mr. Finn Pratt Secretary of the Department of Families, Housing, Community Services and Indigenous Affairs and Mr. John Bradley Director General of Department of the Premier and Cabinet to become permanent Commonwealth and Queensland Government representatives on the Integrated Service Delivery Board of Management.

Name Change from Torres Strait to Zendath Kes

The Premier Ms Anna Bligh MP has provided feedback regarding request from Leaders and Elders during the 28-29 August 2011 Country Cabinet to change the name of the region to Zendath Kes. To initiate a Place Naming activity, a formal application must be lodged with the Department of Environment and Resource Management (DERM). This request must have support of all local parties and organisations. One option for gauging this support is to hold a referendum that coincides with the March 2012 Local Government elections. The naming of the region could deter our aspirations for regional autonomy.

Tagai State College Strategic Directions

The Executive Officers of Tagai State College sought support from Torres Shire Council and other elected representatives for the College aspirations for Autonomous Schooling (Independent State Schools) and the development of students' accommodation on Thursday Island. Council has supported these strategic initiatives in the past and may reaffirm its political support with the appropriate government organisations/agencies.
