MAYOR'S REPORT

Acknowledgement of Traditional Owners, the Kaurareg People, on whose land we hold our Local Government office.

Appointment of the Chief Executive Officer

I wish to take this opportunity to congratulate Mrs. Dalassa Yorkston on her new appointment to the position of Chief Executive Officer for the Torres Shire Council. Her appointment clearly demonstrates Council's commitment to its vision 'lead, provide and facilitate' leadership in Local Government. Au Esoau for accepting the appointment and I look forward to working with you in addressing the many challenges facing our 'grassroots' communities and region.

Public Housing Tenants Community Forum

A Community Forum conducted on the 5th and 12th July 2012 was held at the Port Kennedy Hall to discuss the long standing issues of Public Housing in the Torres Strait. There were over 100 participants attending these forums, expressing their concerns as tenants regarding the ongoing implementation of mainstream housing policy in our region without prior consultation with constituents. The forum resolved to invite the Member for Cook to facilitate an urgent meeting to honour the Liberal National Party's campaign commitment regarding housing matters. I received a copy of an email on the 13th July 2012 addressed to Hon. Bruce Flegg MP Minister for Housing and Public Works and copies to myself and Member for Cook to address the matters raised. Housing petitions collated and attached to the Housing Minister's letter highlighted 3 points:

- 1) Imposition inappropriate policy and procedures to force tenants to share homes or be subjected to rental increase
- 2) Punitive system that imposes a penalty of taking people to court arbitrarily for arrears without Natural Justice
- 3) Intellectual Property Right of information collected by proposed Rental Review and State Owned and Managed Survey as means of extracting private information from tenants for erroneous use in the public domain.

Action: That there be an emergency housing meeting held on Thursday Island for the community with the representative State and Commonwealth Ministers for Housing and Torres Strait Leaders to resolve these issues immediately.

The Housing Minister Hon Bruce Flegg confirmed in his latest housing press release on 11th July 2012 that Queensland public housing tenants will not be forced to share their homes with other people as part of a shake-up of the system.

Local Leaders Meeting

The Chair of Torres Strait Regional Authority Mr. Toshie Kris, Mayor Fred Gela of the Torres Strait Regional Council and I met on the Wednesday 11th July 2012 to discuss matters of regional significance including the establishment of the Health Hospital Service and the nomination of a Torres Strait representative on the Regional Development Australia Far North Queensland Board (RDA FNQ). The Leaders agreed to conduct a regular monthly meeting to discuss regional priorities and ensure our issues are not compromised by States, Territories and National agendas.

It is equally important that each organization is kept abreast of local or homeland challenges. I expressed my disappointment that Torres Shire Council was overlooked in being involved with Minister Simeon Crean's recent visit to the Torres Strait

It is an insult to hold this consultation after the Government has already passed this racist legislation which clearly does not recognize traditional hunting as part of the Torres Strait Native Title Rights.
