Electoral (Redistribution Commission) and Another Act Amendment Bill 2015

A submission was made to the Legal Affairs and Community Safety Committee regarding the Electoral (Redistribution Commission) and Another Act Amendment Bill 2015. The objectives of the bill are to:

- Provide for broader representation in the Redistribution Commission by increasing the
 membership of the Commission from 3 to 5 members. In the interests of transparency, the
 appointments of all Commissioners, with the exception of the Electoral Commissioner
 who has already undergone a separate appointment process, be subject to the approval of
 the leaders of all recognised parties represented in the Legislative Assembly.
- Implement a recommendation by the Electoral and Administrative Review Commission by providing that the independent Redistribution Commission has the ability to determine the number of electoral districts in the Legislative Assembly, subject to a maximum increase of up to 5 additional electoral districts, i.e. the total seats in the assembly would at the commissions discretion be between 89 and 94.
- Provide that Queenslanders have more equitable access to representation in the Parliament by legislating for the Redistribution Commission to have the capacity, at its discretion, to amend the additional large district number, currently set at 2%, up to 4%. Council's submission was supportive of an increase in the number of electoral districts in the Legislative Assembly. The submission also supported the proposal to legislate for the Redistribution Commission to have the capacity, at its discretion, to amend the additional large district number, currently set at 2%, up to 4%. In addition, a concern was raised with the continuation of large size electorates which have the potential for underrepresentation of electors, especially living in remote indigenous communities. 'One Boat' Regional Governance for the Torres Strait was included in the submission to support the submission lodged by Torres Strait Island Regional Council (TSIRC).

A copy of the Electoral (Redistribution Commission) and Another Amendment Bill 2015 submission is attached for Councilor's reference.

Through my Office, Council has provided Volunteer Marine Rescue (VMR) a letter of support towards their application to Queensland Government Gambling Community Benefit Fund for a Grant for a Forward Looking Infrared Unit (FLIR).

Representation to the TRAWQ Indigenous Corporation Meeting

On Saturday 12 September 2015, I was invited to give a presentation to the TRAWQ Indigenous Corporation meeting on Homeownership matters. In attendance were our CEO Dalassa Yorkston and the new Acting Area Manager for the Thursday Island Housing Service Centre, Ms Roshi Ahkil. During the presentation, I advised the members of the process for the 'Sale to Tenants' program currently offered by the Department of Housing. This included the conditions of sales and steps required to undertake the program. The members were provided with the 'Sales to Tenants' *Buying Your Department-owned Home* leaflet which is attached for Councillors' information and circulation. A large aerial map of Thursday Island was available for members to locate their respective residential lots and to understand the land tenure title. It was noted with Quarantine and Waiben Estates that individual houses were not mapped.

Engineering Certification

3. A Registered Professional Engineer of Queensland shall certify engineering drawings and specifications for all engineering works, which shall be submitted in conjunction with an application for Building Works and/or Operational Works.

Water Supply and Sewerage Works

- 4. The approved Special Purpose must be connected to Council's reticulated water supply in accordance with Council's Development Standards and to the satisfaction of the Council's Delegated Officer, prior to the Commencement of Use.
- 5. The approved Special Purpose must be connected to Council's reticulated sewerage system in accordance with Council's Development Standards and to the satisfaction of the Council's Delegated Officer, prior to the Commencement of Use
- 6. The applicant/owner is responsible for the relocation of water and sewer infrastructure. Detailed Engineering drawings indicating existing and proposed locations of infrastructure to be submitted to Council for approval prior to the issue of Operational Works permit.

Electricity

- 7. The applicant/owner must submit satisfactory evidence from Ergon Energy that:
- Electricity is available to the approved development; or
- b. An agreement has been made between the landowner and Ergon Energy to supply electricity to the proposed development.
- 8. Evidence is to be provided prior to the issue of Operational Works permit.

Telecommunications

- 9. The applicant/owner must submit satisfactory evidence from telecommunications authorities that:
- a. Telecommunication services are available to the approved development; or
- An agreement has been made between the landowner and a telecommunication provider to supply telecommunications services to the proposed development.
- 10. Evidence is to be provided prior to the issue of Operational Works permit.

Stormwater

- 11. All stormwater within or entering the site must be controlled in such a manner so that it does not cause any public health or safety concerns and/or damage or loss to property and building for subject site or downstream of the subject site.
- 12. Any stormwater leaving the site must be discharged to the satisfaction of Council's Delegated Officer. Stormwater from the site must not cause nuisance to any adjoining properties.

Lawful Point of Discharge

- 13. The applicant/owner must ensure that the flow of all external stormwater from the property is directed to a lawful point of discharge such that it does not adversely affect surrounding properties or properties downstream from the development, all to the requirements and satisfaction of Council's Delegated Officer.
- 14. The lawful point of discharge will be the drainage gully pit located adjacent to the south western point of the lot fronting Victoria Parade.

Public Utilities

- 15. The applicant is responsible for the cost of any alteration to public utilities as a result of complying with conditions of this Development Permit.
- 16. Any damage caused to any public utility during the course of construction shall be repaired to the satisfaction of Council's Delegated Officer and at no cost to Council prior to the Commencement of Use.
- 17. Any alteration of any public utility or other facilities necessitated by the development of the land or associated construction works external to the site shall be at no cost to Council.

External Works

- 18. The applicant is responsible for the construction of roadworks and drainage on the northern, eastern and southern frontage of the lot in accordance with the Council standards, based on the FNQROC Development Manual.
- 19. Design of the roadworks must incorporate appropriate drainage, street lighting etc and a 2 coat bitumen sealed road. Council will undertake the design, including necessary survey and engineering consultant engagement & project management to allow for operational works drawings including the preparation of tender documents.
- 20. The cost of the design and construction shall be split between Council and the applicant on a fifty-fifty basis being payable by the applicant/owner prior to the issue of the Operational Works Permit.

These conditions have been imposed under Section 665 of the Sustainable Planning Act 2009.

ADVICE NOTE

Council and the applicant may enter into an Infrastructure Partnership Agreement under Section 667 of the Sustainable Planning Act 2009 in order to further clarify the obligations of the parties, manage the nature of cost sharing and the timing at which works and payments are required.

Erosion and Sediment Control

21. The applicant/owner shall prevent erosion and sediment export from leaving the site. Site control measures such as silt fencing, controlled gravel access to the site and controlled disposal of waste, may be necessary.

Plans detailing the methods of controlling erosion and sediment are to be submitted for endorsement by Council's Delegated Officer prior to the issue of a Operational Works permit.

Vehicle Parking

22. The parking must be constructed in accordance with Council's Development Standards prior to the Commencement of Use and must be maintained and kept available for parking at all times, both to the requirements and satisfaction of Council's Delegated Officer. In particular, all parking, driveway and vehicular manoeuvring areas must be imperviously sealed with a concrete or bitumen finish, drained and line marked.

Internal Driveway

23. Construction of internal driveways is to be to the requirements of the FNQROC Development Manual. Engineering drainage must be submitted for approval by Council's Delegated Officer prior to issue of an Operational Works permit. A sealed access driveway must be provided as shown on the approved plans to the parking and manoeuvring areas of the development. The works must be undertaken in accordance with the requirements of the FNQROC Development Manual and an Operational Works approval.

Noise and Lighting

24. All potential noise sources including refuse collection areas and air conditioners shall be installed and located in a manner which prevents noise nuisance beyond the subject site in accordance with the nuisance provisions of the Environmental Protection Regulation 1998.

Ensure external lighting does not spill over into any sensitive surrounding uses.

Landscaping Plan

25. The applicant is required to provide a 2m landscaped area (excluding the driveway) along the southern, eastern and northern frontage of the site. The applicant/owner must provide a plan detailing the proposed landscaping for endorsement by Council's Delegated Officer prior to the issue of an Operational Works Permit.

The landscaping plan must detail:

- a. Location of plantings for the site;
- b. Types of species to be used;

All landscaping works must be provided in accordance with the approved plan prior to the Commencement of Use.

26. Landscaped areas adjoining the parking area must be protected from vehicular encroachment by a 150mm high vertical concrete kerb or similar obstruction, which must be approved by Council's Delegated Officer prior to the issue of a Development Permit for Building Work.

Refuse Storage

27. The applicant/owner must provide a refuse bin enclosure in suitably screened, imperviously paved area large enough for storage of refuse containers in accordance with an Operational Works approval. The refuse bin enclosure must be roofed, bunded and fitted with a bucket trap. An external cold-water tap is to be provided for the facility.

Acid Sulphate Soils

28. The proposed development shall not result in any adverse impact on the surrounding properties and receiving environment as a consequence of the disturbance of acid sulphate soils or the removal or release of surface or groundwater containing acid and metal contaminants.

Environmental

29. The applicant/owner shall be responsible for the complete removal and destruction of any noxious weed or plants existing on the land the subject of the Development Permit.

Costs.

30. All recoverable but unpaid rates, charges and expenses pertaining to the subject land are to be paid in full. Interest and other charges levied on the property are to be paid prior to the Commencement of the Use.

Advertising

31. Any advertising on the site must comply with the requirements of the Advertising Code in the Torres Shire Planning Scheme 2007. Details of advertising must be endorsed by Council's Delegated Officer prior to installation.

ADVICE

- 1. This approval, granted under the provisions of the Sustainable Planning Act 2009, shall lapse four (4) years from the day the approval takes effect in accordance with the provisions of Section 341 of the Sustainable Planning Act 2009.
- 2. The following further development permits must be obtained:
- a. Development Permit for Building Works
- b. Development Permit for Plumbing Works
- c. Development Permit for Operational Works
- 3. The applicant/owner must contribute in accordance with Council's Charges Resolution (No. 1) 2015. Infrastructure Charges are issued through the Adopted Infrastructure Charges Notice attached to this approval. Payment is required prior to the commencement of use.
- 4. No building materials or the like are to be stored on the footpath unless the relevant approval is obtained from Council and the associated fees are paid.
- 5. All building site managers must take all action necessary to ensure building materials and/or machinery on construction sites are secured immediately following the first potential cyclone warning and that relevant emergency telephone contacts are provided to Council Officers, prior to Commencement of Works.
