Indigenous Local Government Disaster Resilience and Recovery Forum – 9-10 October 2019, Cairns

The Torres and Cape Indigenous Alliance Council (TCICA) hosted the Indigenous Local Government Disaster Resilience and Recovery Forum providing councils the opportunity to work with an array of respective State Government agencies and key stakeholders to build council's resilience in preparedness for the upcoming wet season.

The forum gave some useful insight to best equip Councils with an understanding of various tools that can be adopted through the Local Disaster Management Groups. These included weather forecasting tools through the Bureau of Meteorology, Geoscience and the Guardian software. It was also valuable to connect and get first hand advice from relevant key agencies on capability, supply and backup during a disaster event as well as how to mitigate risk on the operations of key infrastructure as well as what steps to take in the recovery stage.

Recommendation

Local Government Association Queensland (LGAQ) 123rd Annual Conference –14-16 September 2019, Cairns

Torres Shire Council was well represented at the recent 123rd LGAQ Annual Conference hosted in Cairns by the Cairns Regional Council.

MAYOR'S REPORT

Local Government Association Queensland (LGAQ) 123rd Annual Conference –14-16 September 2019, Cairns – Cont'd

A packed agenda took place over the 3 days kickstarting with the Indigenous Leaders Forum (ILF) where Mayors and Councillors united to discuss mutual council matters:

- Sustainable Insurance The need for Councils to address the escalating insurance costs currently faced with a case study presented by Torres Strait Island Regional Council.
- Freight and Logistics matters.
- Indigenous Waste Strategy.
- Remote Indigenous Housing.
- State Government Financial Aid (SGFA) Funding.

As a result of discussions, a number of motions were passed by the collective, and these will be presented during this meeting for Council's overall endorsement.

This year's conference theme 'Taking It to The Streets' presented a number of great speakers including showcasing innovative councils such as the Torres Strait Island Regional Council (TSIRC). Further updates were also provided on Belcarra legislative changes including councillors code of conduct and training expectations and new requirements through the Australian Electoral Commission for the 2020 elections.

MAYOR'S REPORT

During the course of the conference 88 motions were tabled for consideration covering various matters from airport security, waste and environmental management, housing, abandoned vehicle, animal management, draught and bush fire management, to name a few.

I had the privilege to put forward motion 8 on behalf of all Indigenous Councils relating to the Uluru Statement from the Heart:

That the LGAQ write to the Australian Local Government Association (ALGA) affirming the support of Queensland councils to the central tenets of the Uluru Statement from the Heart and conferring to ALGA the responsibility for ensuring effective representation of Local Government in the Federal Government's response to the Statement.

Mover: Cr Malone Seconder: Cr Williams (Mayor of Redland City Council)

Mayor Tony Wellington, Noosa Shire Council also extended an additional statement strongly supporting the motion. Noosa Council joined with Cherbourg Aboriginal Shire Council in proposing that the endorsement of the Uluru Statement be considered by the LGAQ annual conference.

The motion was supported by 185 votes to 8 opposed.

This was an historic occasion with Queensland councils publicly declaring their support for constitutional recognition of First Nations people.

1.1 Annual Valuation Effective 30 June 2020

The Valuer-General has written to Council regarding our response to his request seeking Council's opinion on whether or not an annual valuation (effective 30 June 2020) should be undertaken in the Torres local government area. Council had advised that an annual valuation should be undertaken.

The Land Valuation Act 2010 (the Act) requires that the Valuer-General undertake an annual valuation of all land in a local government area except in unusual circumstances or after consideration of:

<u>REPORT</u>

- a market survey report for the local government area which reviews sales of land and the probable impact of the sales on the value of land since the last annual valuation, and
- the results of consultation with the local government for the area and appropriate local and industry groups.

After considering the statutory criteria, the Valuer-General have decided that an annual valuation for the Torres local government area will be undertaken in 2020. In accordance with the Act, annual valuations are required to be issued prior to 31 March in the year the valuation is to take effect.

1.3 Torres Strait Strategic Interagency Forum - On Wednesday 25 and Thursday 26 September 2019 the Torres Strait Strategic Interagency Forum was held on Thursday Island and hosted by the Torre Strait Regional Authority (TSRA). Councillor Gabriel Bani, CEO Dalassa Yorkston and DGPS Maxwell Duncan attended the Torres Strait Strategic Interagency Forum on behalf of Torres Shire Council.

<u>REPORT</u>

Background

On 15 July 2009, Cr Pedro Stephen, on behalf of Torres Shire Council (TSC), Cr. Fred Gela on behalf of Torres Strait Island Regional Council (TSIRC), Mr Toshie Kris, on behalf of Torres Strait Regional Authority (TSRA), Cr. Joseph Elu, on behalf of the Northern Peninsula Area Regional Council (NPARC) were joint signatories to the *Torres Strait and Northern Peninsula Area Regional Plan – Planning for our future 2009-2029.* The Plan set a course towards "a regional partnership with all levels of Government working together to build a strong future for our people".¹

It has been over ten (10) years since the signatories gathered and over that time, there has been three local government terms for TSC, TSIRC, NPARC, as follows:

- 2008 2012
- 2012 2016
- 2016 2020 current term

Over the past decade, the TSRA Board Terms has had three (3) terms.

So much has occurred over this time and thus an important factor moving forward from the September 2019 regional forum is ensuring that collaboration and deliberation of the signatories are not left to a review in 2029. It is critical that a planned process of review and refreshing of the plan is agreed by the signatories.

Indeed, a central element of the Plan was the establishment of an Integrated Planning and Service Delivery Framework and a Steering Group of elected leaders and senior

The elements of this review and conversation may be taken from the Plan itself:

- Identify and document new and emerging issues in the region
- Seek/facilitate strategic planning for resolutions of new problems facing the region
- Monitor implementation of the goals and objectives identified in the Regional Plan
- Periodically review the status of the objective and progress in achieving them and initiate changes where required.²

Having regard to this background, it is recommended that the Joint Signatories agree to hold a Torres Strait Annual Governance Forum to review the TSNPA Regional Plan; and to conduct our own review and conversation around the regional issues of significance.

It is important also to draw on previous plans and work completed for our region over the past decade, in particular the Queensland Productivity Commission (QPC) Report 2018, its findings and its recommendations. Regional issues need to be agreed and collective submissions to enquiries, deputations to both State and Federal governments need to be progressed with the Joint Signatories to the Plan.

Queensland Productivity Commission Report

The QPC Report identified complex governance and service delivery arrangements in the region; duplication of services; and over-governance in the region. Its recommendations also included a recognition that the Torres Strait has a strong aspiration for our future governance arrangements that was previously enshrined in the One Boat Strategy at the Joint Leaders Forum on Thursday Island, 6 May 2014.

The Queensland Government's response to the QPC Report was to adopt the Thriving Communities Partnership. It was the TSNPA Regional Plan in 2008 that set the blueprint for the Thriving Communities Partnership in 2008.

Noting the TSNPARP has been developed from the ground up through the community booklet process, opportunities need to also be provided where the community contribute to the review and provide feedback of their plans.
