- 6. Written advice to Exhume Remains will be given by the Torres Shire Council when application is approved.
- 7. All works to be conducted in accordance with Occupational, Health and Safety requirements.
- 8. Torres Shire Council charge a fee for service for each application to the value of \$520.00
- 9. Adhere to cultural and traditional practices and protocols "
