# **BUSINESS ARISING AND MATTERS FOR ACTION FROM PREVIOUS MEETING**

# **COVID19 Response**

Torres Shire Council (TSC) continues to be actively engage in a series of meetings in response to COVID19:

- 1. Chief Health Officer meeting with Mayors 21 July 2020
- 2. Premier and Mayors Meeting 31 July 2020
- 3. Torres and Cape Hospital and Health Services (TCHHS) meeting with TSC 4 August 2020
- 4. Premier and Mayors Meeting 5 August 2020
- 5. TSLDMG Executive Meeting 11 August 2020
- 6. Australian Border Force (ABF) Meeting with TSC 11 August 2020
- 7. Qld Remote and Discrete Communities Meeting 13 August 2020

Key issues discussed over the various meetings include:

- Closure of the Qld Border to NSW and ACT and the management of the border.
- Drafting of TSLDMG response and activation plan pending the second wave of COVID-19 emphasising certain trigger points including Cairns, Cape and Top Western communities.
- PNG/Australia International Border and enhancement of surveillance of the hard border by law enforcement agencies
- COVID-19 cases in PNG and Australia's support to PNG particularly in Western Province.
- Point-of-Care (POC) Testing rollout and further POC needed for Boigu Island.

The current hot spots are Victoria, ACT and New South Wales.

# TSC Technical Working Group - 22 July 2020

The first TSC Technical Working Group (TWG) meeting was held on 22 July and it was specifically setup to walk through Councillors and staff on the role of the TWG. The TWG is a mechanism that facilitates a whole-of-government approach to infrastructure development. The TWG is designed to get the right people at the table to make timely decisions and accelerate council's/community aspirations. In the past term TSC held joint TWG's with TSIRC covering matters across the whole region. TSC has now matured to hold its own specific meeting to be more focused on Torres Shire matters and progress our projects in a timely manner.

It was highlighted that the TWG leverages off the expertise that DATSIP's Remote Indigenous Land and Infrastructure Program Office (RILIPO) offering expertise to infrastructure works covering:

- Tenure Resolution
- Home Ownership
- Cultural Heritage
- Native Title
- Land Development
- Land Holding
- Survey and Town Planning
- Economic Participation
- Integrated Capital Works
- Master Planning

At the initial meeting a number of key matters were discussed including the review of the draft terms of reference, major projects for standing agenda items, frequency of meeting and timing. The next meeting is scheduled for 26 August in Cairns.

#### **MAYOR'S REPORT**

# Torres and Cape Indigenous Councils Alliance (TCICA) Remote Indigenous Housing – 28 July 2020

TCICA held a videoconference with Minister Mick de Brenni to followup on the allocation of the \$105m Commonwealth funding for housing. The outcome of the discussions included:

- First \$5 million transferred to the Queensland Government.
- Remaining \$100 million will come <u>after</u> the Commonwealth Budget is handed down in October.
- Will take some time before the \$100 million is then passed to the State, eg will not be with the Queensland Government before the election on 31 October 2020.
- The flow of funds to Councils will be contingent upon the sign-off of local housing plans.
- Minister cannot guarantee that funding for housing will be retained following the election if Labor is not re-elected.

A workshop is planned to coincide with Community Cabinet in Cairns on 25 August, to discuss where planning for new housing is at, the development of local housing plans, and next steps going forward as well as:

- The local housing plans are needed to help provide clarity about how Councils will deliver new housing in their communities.
- Local housing plans do not need to be completed by the August workshop, however councils
  are urged to work on them now to ensure construction of new housing can get underway as
  soon as funding flows.
- It was noted that some communities have not been contacted as yet by DHPW to discuss the development of local housing plans.

# Commitment to establishing Aboriginal and Torres Strait Islander housing body

- COVID-19 has challenged the tender process for the establishment of a housing body, however DHPW expects to go to a select tender next week.
- Decision on an auspicing body to be made in September, with arrangements in place by the end of 2020.
- DHPW will provide an update on the establishment of an Aboriginal and Torres Strait Islander housing body at the workshop in August.

# TCICA Out-of-Session Meeting – 12 August 2020

TCICA's out-of-session meeting enabled members to regroup to address the following:

- COVID-19 Discussion held on status and concerns under Stage 3.
- Extension of Section 24JAA Discussion with Dr Nathan Boyle, Senior Adviser, Housing Branch, NIAA on section 24JAA, Native Title Act. The Australian Government is conducting targeted consultations on the possibility of retaining section 24JAA on a temporary basis. LGAQ on behalf of Indigenous Councils put forward an application to the Commonwealth through Minister Wyatt to issue a further 10 year extension.
   Section 24JAA has been instrumental in the delivery of essential infrastructure, in particular with the rollout of public houses and critical infrastructure. TCICA supported the further extension aligned to LGAQ's request.
- Cape York NRM and appointment of local government director vacancy.

# Teleconference with Minister Keith Pitt, Minister for Resources, Water and Northern Australia – 13 August 2020

TCICA held a meet and greet with Minister Keith Pitt who was recently appointed to the Northern Australia portfolio superseding Senator Matt Canavan. Minister Pitt gained an appreciation on the makeup and mandate of TCICA. An overview of TCICA's priorities was highlighted and questions were posed on potential larger economic initiatives including expansions of airports, marine facilities and the Peninsula Development Road.

### **MAYOR'S REPORT**

# **Torres Strait Boarding Facility - 5 July 2020**

Mr Ned David, TSIREC facilitated a meeting with TSC, TSRA and Minister Shannon Fentiman, Torres Strait Champion to progress the Torres Strait Boarding Facility. The facility is scheduled to be established on Horn Island within the Horn Island TAGAI primary school precinct. The funds allocated by the State will enable 24 beds as part of stage 1. It was agreed that community input via a reference group was required as oversight to the project and to ensure that the tender and building works enabled maximum local employment outcome. The State is in the process of commencing the tender process.

# Parliamentary Committee - Meriba Omasker Kaziw Kazipa (Torres Strait Islander Traditional Child Rearing Practice) Bill 2020 - 6 August 2020

TSC met with the Parliamentary Committee and Ms Cynthia Lui, Member for Cook, to provide feedback on the Bill and put forward TSC's submission. Some key points tabled with the Committee included and as outlined in TSC submission included:

- The limited consultation process within the Torres Strait now adequately covering the different clusters of Western and Eastern Islands.
- Concerns on inadequate timing for thorough consultation.
- Definitions and terminology within the Bill.
- The complexity of the proposed structure and the practical application and use by Torres Strait Islander families.
- The need for appropriate community guidance to support the decision making of the Commissioner.

Following TSC's deputation the committee held a public consultation meeting at the TRAWQ Hall and also allowing members of the public to engage in private hearings. The committee is required to report back to Parliament on this process by Friday 28 August 2020.

# **OBON – 15 August 2020**

TSC hosted the Japanese OBON ceremony jointly with the Consular-General of Japan Mr Naohio Hayakawa and the Reverend Jim Wilson (Tetsuyu), Jodoshu Buddhist Priest. During the ceremony Mr Hayakawa expressed sincere thanks on behalf of the Japanese Government for the collaboration and respectful relations established with TSC. Mr Hayakawa and the Consulate was also pleased with the good progress achieved by TSC and the Japanese families on the gravesite marking project initiated last year. The Brisbane Consulate is keen to continue to complete this project and would like TSC to formally write to reignite stage 2.

## Recommendation:

# COVID-19 Second Wave - Torres Shire Council Response & Activation Plan

A COVID-19 Second Wave Response & Activation Plan has been developed by the Torres Shire Council to ensure risks and issues associated with the triggering of regional restrictions around a coordinated framework and its implementation.

Council sought the TSLDMG agreement and have identified the following trigger points as a precondition to the reintroduction to Stage 2 restrictions.

Torres Shire Council and the Queensland Government, in consultation with Aboriginal and Torres Strait Islander Communities, will continue to initiate emergency requirements determined under the relevant Acts by the Minister for Health, which aim to restrict people from entering designated areas as it is necessary to do so.

# **Growing Indigenous Tourism in Queensland Fund Expression of Interest**

Minister for State Development, Tourism and Innovation, Hon, Kate Jones had called for Expression of Interest for the \$7 million Growing Indigenous Tourism in Queensland Fund as part of the Year of Indigenous Tourism to grow and support jobs for Aboriginal and Torres Strait Islander Queenslanders.

Torres Shire Council's Expression of Interest has been successful in progressing to Full Application in accordance with the funding guidelines. Councils application was for the maximum under the fund (\$1 million) towards the \$3.2 million required to deliver the Tourism Information and Business Centre Facility on Thursday Island.

# Rescinding of Funding for Investigative Study by TMR towards the Thursday Island Boat Ramp

The Thursday Island Boat Ramp at Rose Hill suffers from significant congestion and spatial design issues, which pose a significant risk to Community.

On the 2 June 2020, the Torres Shire Council was pleased to receive formal approval from Transport and Main Roads (TMR) to fully fund further investigations, planning and design works for the Thursday Island Boat Ramp. This decision to fund Council has since been rescinded and no clear reason has been presented to Council.

Boat ramps numbers were holistically measured across the Local Government Area (LGA). The overwhelming number of the LGA's population is based on Thursday Island. For an island LGA, the analysis should have been divided between islands, landing sites and their respective ramps.

TMR reports do not consider landside area congestion – they are non-compliant and unsafe due to no formalised carparking, wayfinding and pedestrian/vehicular separation.

The usage of the landing facility as a commuter point between Islands (particularly Hammond) and the effects this has to the operation of the ramp itself has not been quantified (instead, it appears to have been intentionally omitted). Demand Assessment did not consider the high frequency of boat usage specific to the area.

#### **Council Actions**

Council has implemented significant strategic, financial and business initiatives by taking the first steps in analysing, identifying and raising this issue. A Preliminary Demand Analysis – Thursday Island Multi-purpose Maritime Facility (May 2020) which further details and articulates the background, need and justification for urgent investigations.

# **New Torres Shire Council Planning Scheme**

A new Torres Shire Council Planning Scheme (the Scheme) has been assessed by State Government representatives of the Minister for State Development, Manufacturing, Infrastructure and Planning for State Interest Review.

As a consequence of the review, minor amendments have been proposed to the Scheme. Representatives of the Department of Aboriginal and Torres Strait Islander Partnerships (DATSIP) together with Council's planners propose to report to Council on the State's requested changes prior to the Council meeting in October 2020.

Thereafter, the following draft schedule is proposed, so that the Scheme may proceed to the consultation phase and final State Government approval:

- Council to consider the amendments to the Scheme and approval of a Scheme at it's Ordinary Meeting of 20 October 2020: The following documents will be considered.
  - The consultation draft Planning Scheme;
  - o The consultation draft Local Government Infrastructure Plan (LGIP); and
  - A Schedule for Public Consultation.
- Should Council approve the Scheme and LGIP, the public consultation phase will commence in mid-November and run until mid-January 2021. The public consultation will consist of:
  - Public notices in newspapers and at Council buildings and local community signboards;
  - Copies of the proposed Scheme being made available for inspection on Thursday Island, Horn Island, Prince of Wales Island and at Seisia as well as on Councils Website; and
  - Community consultation opportunities at Thursday Island, Horn Island, Prince of Wales Island and at Seisia, so that the community will have the opportunity to ask questions and/or clarity aspects of the scheme.
- At the conclusion of the consultation period, a submissions' paper will be prepared for the consideration of Council at its Ordinary Meeting in February 2021.
- Should Council approve the final draft Scheme and LGIP, the documentation will be presented to the State for approval in March/April 2021.



The three allotments have been developed for residential purposes by DHPW with relatively new structures on the sites.



In the draft Scheme as currently proposed the sites are zoned industrial. The rationale for the zoning was to link the industrial land on Horn Island at the harbour and airport.

DHPW request that the three sites be retained with a Residential zoning as indicated in the current Planning Scheme. The rationale is to protect the current occupants.

DHPW furthermore request a buffer to the three properties to provide amenity to the residents. This buffer could be provided through the proposed road (shown in blue) to the east of the three properties and the retention of a Residential zoning to the single dwelling to the west (shown in yellow) of the three properties. DHPW and the single residence share a combined driveway in the form of an easement over both properties.



The future intent of Council to allow Industrial type uses to the north of Airport Rd will be entrenched in the Strategic Intent part of the draft Scheme clearly indicating that the properties namely three DHPW residential properties and the single residential property will over time be allowed to be developed for Industrial purposes should the use change.

# **Animal Management**

During May and June 2020 animal management compliance activities were significantly affected by the delay in obtaining the necessary pharmaceutical products (schedule 1 Narcotic), occasioned by the biosecurity restrictions. This obstacle has now been overcome and animal management compliance activities have recommenced. The focus of these activities are the significant dog and cat populations on Thursday and Horn Islands.

The animal management statistic for both months are set out hereunder:

Dogs impounded nine (9)
Dogs euthanised nine (9)

Cats impounded eleven (11)
Cats euthanised eleven (11)

A veterinary visit was conducted between 7- 9 August 2020 on Thursday Island. The visit was well attended with over fifteen consultations each day. Thirteen dogs were de-sexed.

Animal management and compliance remains a challenge for Council, particularly on Horn Island. An animal management officer has commenced work on Horn Island, which has enhanced the implementation of the TSC animal management plan.

# The plan includes:

- community education and awareness sessions on Horn Island to advise of the need for dog and cat registration and the availability of veterinary assistance and de-sexing services;
- · responsible dog and cat ownership;
- · local law (animal management) enforcement to encourage registration; and
- · local laws enforcement.
